



Adopt-a-Block Statement of Commitment – 2years School or Organization

The Mission Adopt-a-Block Society is supported by the District of Mission and is a cooperative effort between the society and the citizens of the District who wish to contribute to the appearance of their community. Both parties therefore commit to each other to perform certain activities for keeping cleaner and safer streets, trails, parks and creeks.

It is understood that at no time is the safety of any volunteer to be compromised in the performance of cleaning activities.

THE SCHOOL or ORGANIZATION agrees to:

1. Remove litter along two kilometer or more section of Municipal street once a month for a minimum of two years or, in the case of a trail or park, remove litter in the specific section of trail or park at least two times a month, or for a creek, remove litter four or more times per year, for a minimum of two years. After each clean up, provide a participant record form detailing efforts (This is mandatory for all groups that receive AAB signage).

2. Designate a Contact Person who will assure that all participants are responsible people and that all participating minors under the age of 18 are provided with adult supervision and have obtained parental/guardian permission to participate in the program. The Contact Person will discuss safety precautions with participants and ensure that the appropriate tools and equipment are used during clean-up.
3. Avoid direct contact with items that have the potential to be hazardous or injurious. Items such as syringes, condoms and animal parts shall not be touched. Hazardous litter and exceptionally heavy or unyielding objects shall be reported immediately to the AAB Coordinator.
4. Report to the AAB Coordinator any injury incurred by any participant during clean-up activities. The injury will be reported within two working days of the incident and shall include:

- a. The name of the injured person
- b. The time and date of the incident
- c. The nature of the injury
- d. Details of the incident
- e. The name of any hospital or clinic attended

5. Notify Mission Adopt-A-Block upon discontinuation of work and return all equipment. (\$30 unreturned kit charge)

THE MISSION ADOPT-A-BLOCK SOCIETY agrees to:

1. Supply operating materials which may include, but is not limited to, safety vests, litter bags, and litter pickers.
2. Arrange for the removal and disposal of any litter and materials collected from the designated street, trail, park or creek if necessary.
3. **Provide a Safety Orientation**
4. Supply and install recognition sign(s) with the adopter's name on the sign when the adopter has satisfactorily performed the duties stated in this agreement: For Adopt-a-Street and Adopt-a-Trail, two signs will be installed, one at either end, of the designated section of street or trail. For Adopt-a-Park, one sign will be installed under the main park sign. For Adopt-a-Creek a sign may or may not be installed and instead a plaque may be issued.

Release and Waiver Agreement Adopt-A-Block Program

TO: THE CORPORATION OF THE DISTRICT OF MISSION, ITS OFFICERS, EMPLOYEES, DIRECTORS and VOLUNTEERS AND THE MISSION ADOPT-A-BLOCK SOCIETY (together called "THE RELEASEES").

ASSUMPTION OF RISK

I am aware that engaging in an Adopt-A-Block activity may involve certain risks, dangers and hazards, including, but not limited to picking up dangerous debris and collision with passing traffic. I agree to ensure that all our organizations participants wear a safety vest and use proper tools (such as gloves, tongs and/or EZ Reachers) while participating to minimize any such risks and I freely accept, and fully understand and assume all risks and dangers and the possibility of personal injury, death, property damage or loss resulting therefrom including NEGLIGENCE, BREACH OF CONTRACT; OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT R.S.B.C. 1996, C.337 on the part of the Releasees.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

By participating in the Adopt-A-Block program I hereby agree on behalf of myself and my organizations participants as follows:

1. TO WAIVE ANY AND ALL CLAIMS that myself and our organization participants have or may in the future have against the Releasees.
2. TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury or expense that I/we may suffer or that my next of kin may suffer as a result of participating in the Adopt-A-Block program due to any cause whatsoever, including negligence on the part of the Releasees and including NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT R.S.B.C. 1996, C.337 on the part of the Releasees.
3. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES for any and all liability for any property damage or personal injury to any third party, resulting from our organizations participation in the program.
4. This Release shall be effective and binding upon myself and our organizations participants heirs, next of kin, executors, administrators and assigns, in the event of any one of ours death.

I have read this Release prior to signing it and I understand its effect. I am aware that by signing this Release I am waiving certain legal rights which I, my participants or my heirs, next of kin, executors, administrators and assigns may otherwise have had against the RELEASEES.
